

## **TERMS AND CONDITIONS OF ENTRY**

1. The name of the competition is the “Luxottica Summer Rewards 2020” (“the Competition”).
2. Information on how to enter the Competition and the entry registration process forms part of these terms and conditions of entry and is the property of the Promoter. Entry into the Competition is deemed acceptance of these terms and conditions.
3. The Promoter of the Competition is Luxottica Retail Australia Pty Ltd (ABN 26 000 025 758) of 75 Talavera Rd, Macquarie Park NSW 2113 (“the Promoter”).
4. To enter the Competition, entrants at the time of entering must be over the age of 18, legal residents of Australia or New Zealand and staff members of a participating retail store with whom the Promoter has a wholesale agreement (“Staff Entrant”) or a participating retail store with whom the Promoter has a wholesale agreement (“Store Entrant”).
5. The Competition will commence at 12.01am 29 October 2020 and entries will close at 11.59pm on 25 February 2021 (“the Competition Period”). All times in these terms and conditions are expressed as the local time in Sydney, Australia.
6. To enter the Competition, during the Competition Period, the Staff Entrant must:
  - (a) register for the Competition on <http://www.luxotticarewards.com.au> (“the Website”);
  - (b) enter/update his/her personal details;
  - (c) confirm his/her ID and password; and
  - (d) accept participation in the Competition.
7. An eligible sale (“Eligible Sale”) consists of the sale at a participating retail store in Australia or New Zealand by a Staff Entrant during the Competition Period of:
  - (a) one (1) pair of Luxottica-branded, non-prescription sunglasses from the following brands: Bvlgari, Prada, Prada Linea Rossa, Oakley, Arnette, Persol, Polo Ralph Lauren, Michael Kors, Miu Miu, Emporio Armani, Dolce & Gabbana, Ralph Lauren, Ray-Ban, Tiffany & Co, Versace, Vogue, Coach, Oliver Peoples, Valentino, Chanel and Burberry; or
  - (b) one (1) pair of Oakley prescription lenses in an Oakley branded frame (for the avoidance of doubt, the sale must include both the Oakley lenses and the Oakley branded frame)
8.
  - (a) Staff Entrants will earn one (1) point for each Eligible Sale he/she records on the Website. Staff Entrants will earn one and a half (1.5) points for each Eligible Sale he/she records on the Website with Polar, Prizm or Chromance lenses. Staff Entrants can also earn one and a half (1.5) points for each Eligible Sale he/she records on the Website for Luxottica luxury branded sales for the following brands: Prada Linea Rossa, Burberry, Chanel, Miu Miu, Bvlgari, Tiffany & Co, Prada, Dolce & Gabbana, Oliver Peoples, Valentino & Versace (“Luxury Frames”). Staff Entrants can also earn three (3) points for each sale he/she records on the Website for Oakley prescription sales that are made up of Oakley prescription lenses in an Oakley branded frame at a participating retail store in Australia or New Zealand during the Competition Period (for the avoidance of doubt, the sale must include both the Oakley lenses and the Oakley branded frame). The maximum amount of points a Staff Entrant can earn from any Eligible Sale is one and one half (1.5) points except for the three (3) points (in total) for an Eligible Sale of Oakley prescription lenses in an Oakley branded frame.
  - (b) Staff Entrants may also earn points for successfully completing “training modules” during the Competition Period at the “Luxottica University portal” at <https://my.luxottica.com> as follows:
    - (i) One (1) point for each training module on Luxottica University portal successfully completed by the entrant during the Competition Period;
    - (ii) The first training module successfully completed during the Competition Period for each entrant will be worth 5 points; and
    - (iii) Entrants are limited to a maximum of fifteen (15) points in total for all training modules successfully completed during the Competition Period.

In addition to the above, a Staff Entrant may also earn five (5) bonus points for each of the “virtual classrooms” he/she/they successfully complete during the Competition Period at the “Luxottica University portal” at <https://my.luxottica.com> (to a maximum of thirty (30) points in total – 5 bonus points for each of the 6 topics) as listed below:

- (i) How to learn & earn more with Luxottica University;

- (ii) The Love of Giving Tiffany 2020;
- (iii) The Art of Selling Prada 2020 Collection;
- (iv) Learn how to sell Oakley Prizm Lenses this Summer;
- (v) Boost sales with Ray-Ban Then & Now; and
- (vi) Learn More, Sell More, Versace 2020.

Points earned for successfully completing training modules or virtual classrooms will be added to the entrant's points statement within 7 business days from completion but will be added by no later than 11.59pm on 1 March 2021.

In addition to the bonus points Staff Entrants may earn for completing virtual classrooms during the Competition Period at the Luxottica University portal at <https://my.luxottica.com>, each entrant may also be eligible to win the following prizes:

- (i) A Staff Entrant will be awarded a \$25 Uber Eats voucher for registering (at least one (1) hour before the start time) for the following "virtual classrooms":
  - (a) How to learn & earn more with Luxottica University, 11 November 2020 at 5.30pm EDST / 4.30pm EST, 5.30pm local Brisbane, Queensland time and 4.30pm local Perth, Western Australia time;

  - (d) Learn how to sell Oakley Prizm Lenses this Summer, 2 December at 5.30pm EDST / 4.30pm EST;
  - (e) Boost sales with Ray-Ban Then & Now, 9 December at 5.30pm EDST / 4.30pm EST; and
  - (f) Learn More, Sell More, Versace 2020, 16 December at 5.30pm EDST / 4.30pm EST.

Only one (1) \$25 Uber Eats voucher will be awarded to an entrant for each topic of the above listed virtual classrooms (to a maximum of six (6) vouchers if registration has been made to all virtual classroom topics) however an entrant may only be awarded an additional Uber Eats voucher if he/she/they attend the previously registered virtual classroom. The voucher will be provided to the entrant electronically by the Promoter on or around the day of the relevant virtual classroom. Each voucher is valued at up to \$25.
- (ii) The Staff Entrant who records the highest score in the quiz at the end of the virtual classroom topic as mentioned above will win the following voucher:
  - (g) How to learn & earn more with Luxottica University - \$200 Amazon voucher;
  - (h) The Love of Giving Tiffany 2020 - \$200 Good Food voucher;
  - (i) The Art of Selling Prada 2020 Collection - \$200 Day Spa voucher;
  - (j) Learn how to sell Oakley Prizm Lenses this Summer - \$200 Virgin voucher;
  - (k) Boost sales with Ray-Ban Then & Now - \$200 Moshtix voucher; and
  - (l) Learn More, Sell More, Versace 2020 - \$200 Red Balloon voucher.

Six (6) highest score prizes will be awarded (one for each topic) in total. The voucher will be provided to the entrant electronically or in physical format (at the discretion of the Promoter) by the Promoter.

In the case of a tie, the Promoter may require the tied Staff Entrants to answer as many tiebreak questions (on such terms stipulated by the Promoter) as required by the Promoter to determine a winner.

Each voucher is valued at up to \$200.

(c) Only one (1) Staff Entrant can earn a point from an Eligible Sale he/she is personally involved in and each Eligible Sale can only count once in the Competition. The Promoter reserves the right to undertake spot checks of sales and ask for the Staff Entrant to provide proof of sale documentation at its discretion. Pooling of points to an entrant in a participating retail store is strictly prohibited and the Promoter reserves the right to disqualify an entrant and/or deduct points from an entrant where the entrant was not personally involved in the Eligible Sale recorded on the Website or the Promoter deems, in its sole discretion, pooling of points to an entrant in a participating retail store has occurred. If products are returned points for that Eligible Sale will be deducted.

(d) Each Eligible Sale must be recorded via the “claim a sale” menu on the Website by the Staff Entrant. Staff Entrants must complete all required details and upload all required materials including but not limited to a copy of the original invoice that records the eligible product(s) sold, date of sale, receipt/invoice number and store details. Hand written receipts will not be accepted as proof of sale. Points for Eligible Sales will be awarded to the entrant’s account after the Promoter has verified the recorded Eligible Sales.

(e) Staff Entrants will earn five (5) additional points for registering for the Competition on the Website before 11.59pm on 12 November 2020. The additional points earned for registering for the Competition on the Website before 11.59pm on 12 November 2020 will be added to the entrant’s points statement by no later than 11.59pm on 13 November 2020.

9. The Promoter accepts no responsibility for late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, claims or correspondence whether due to the Staff Entrant’s error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption, communications failure or otherwise. The Promoter is not liable for any consequences of user error including (without limitation) costs incurred. All inaccurate and/or incomplete entries will be deemed invalid.

10. Staff Entrants may be eligible to redeem points from the six (6) different tiers of prizes as detailed below. Staff Entrants who are residents of New Zealand are limited to redeem points for prizes from Tiers 1, 2 and 3 only as provided below. Prize redemptions can only be made once the Staff Entrant has reached the defined points interval during the Competition Period as specified below for the corresponding prize tier.

- (a) Tier 1 prize is available to a Staff Entrant who has earned thirty (30) points in the Competition. The prize for Tier 1 is a pair of Luxottica branded sunglasses up to the recommended retail price (“RRP”) of \$360 in the following brands: Arnette, Burberry, Coach, Dolce & Gabbana, Emporio Armani, Michael Kors, Oakley, Persol, Polo Ralph Lauren, Prada, Prada Linea Rossa, Ralph Lauren, Ray-Ban, Versace and Vogue. The prizes in this tier are subject to availability and valued at up to \$360 RRP. In the event an entrant’s selection is not available, the Promoter will contact the entrant via email and the entrant must respond within thirty (30) days with a second selection. In the event the entrant does not respond within the time allowed the entrant’s claim to the Tier 1 prize will be forfeited. In the event the entrant’s second selection is not available the Promoter may select a pair of Luxottica branded sunglasses of an equal or higher value to the entrant’s initial selection to award the entrant.
- (b) Tier 2 is available to a Staff Entrant who has earned sixty (60) points in the Competition. The prizes for Tier 2 are a selection of prizes listed on the Website up to the value of \$269.00 RRP. The prizes in this tier are subject to availability and are valued up to \$269.00 RRP. The listed prizes for Tier 2 on the Website will be limited in number and awarded in order of entrant claims lodged – the Website will display a live countdown of the amount of each prize still available to claim. There will be separate allotment of prize availability for Platinum Accounts and Independent Accounts. Staff Entrants who are residents of New Zealand will be limited to redeem points for selected gift cards as indicated on the Website from Tier 2 up to the value of NZ\$150.
- (c) Tier 3 is available to a Staff Entrant who has earned ninety (90) points in the Competition. The prizes for Tier 3 are a selection of prizes listed on the Website up to the value of \$399.95 RRP. The prizes in this tier are subject to availability and are valued up to \$399.95 RRP. The listed prizes for Tier 3 on the Website will be limited in number and awarded in order of

entrant claims lodged – the Website will display a live countdown of the amount of each prize still available to claim. There will be separate allotment of prize availability for Platinum Accounts and Independent Accounts. Staff Entrants who are residents of New Zealand will be limited to redeem points for selected gift cards as indicated on the Website from Tier 3 up to the value of NZ\$300.

- (d) Tier 4 is available to a Staff Entrant of a Platinum Account who has earned one hundred and fifty (150) points in the Competition. The prizes for Tier 4 are a pair of Luxottica branded sunglasses up to the value of \$650 RRP in the following brands: Dolce & Gabbana, Persol, Prada, Prada Linea Rossa, Tiffany & Co, Oliver Peoples and Bvlgari. The prizes in this tier are subject to availability and are valued up to \$650 RRP. In the event an entrant's selection is not available, the Promoter will contact the entrant via email and the entrant must respond within thirty (30) days with a second selection. In the event the entrant does not respond within the time allowed the entrant's claim to the Tier 4 prize will be forfeited. In the event the entrant's second selection is not available the Promoter may select a pair of Luxottica branded sunglasses of an equal or higher value to the entrant's initial selection to award the entrant. The prizes for Tier 4 will be limited in number and awarded in order of entrant claims lodged – the Website will display a live countdown of the amount of prizes still available to claim.
- (e) Diamond Tier (Independent) is available to a Staff Entrant of an Independent Account who has earned two hundred and fifty (250) points in the Competition. The prizes for Diamond Tier (Independent) are a selection of prizes listed on the Website up to the value of \$849 RRP. The prizes in this tier are subject to availability and are valued up to \$849 RRP. The listed prizes for Diamond Tier (Independent) on the Website will be limited in number and awarded in order of entrant claims lodged – the Website will display a live countdown of the amount of each prize still available to claim.
- (f) Diamond Tier (Platinum) is available to a Staff Entrant of a Platinum Account who has earned three hundred and fifty (350) points in the Competition. The prizes for Diamond Tier (Platinum) are a selection of prizes listed on the Website up to the value of \$1,199 RRP. The prizes in this tier are subject to availability and are valued up to \$1,199 RRP. The listed prizes for Diamond Tier (Platinum) on the Website will be limited in number and awarded in order of entrant claims lodged – the Website will display a live countdown of the amount of each prize still available to claim.

11.

(a)

The designation of an account as a "Platinum Account" or an "Independent Account" will be at the sole discretion of the Promoter. The Promoter will inform each participating retail store with whom the Promoter has a wholesale agreement if it has been designated as part of a Platinum Account or an Independent Account.

(b)

Prize selections from the different prize tiers can be selected by the Staff Entrant using points earned during the Competition Period. For example, a Staff Entrant who earns 90 points during the Competition Period can select either one Tier 3 prize or multiple prizes from the Tier 1 and/or Tier 2 prizes that equate to a total value of 90 points (subject to prize availability and residential restrictions). A minimum of 30 points must be earned during the Competition Period for a Staff Member to be eligible to redeem a prize.

12. Points may only be redeemed by the registered entrant and are not transferable. If requested by the Promoter, a winner must sign an indemnity and exclusion of liability deed (provided by the Promoter) in favour of all parties involved in the Competition and/or providing the prize. If a winner does not sign the indemnity form provided by the Promoter within the time requested by the Promoter, the winner's entry or claim will be deemed invalid. Participating retail stores must be free of any overdue debts to the Promoter and any of the Promoter's related body corporate for an entrant (Staff Entrant or Store Entrant) to claim a prize in the Competition.

13. Staff Entrants will be provided a three (3) day grace period to record Eligible Sales by 11.59pm on 28 February 2021 to count towards the prize redemptions as detailed in clause 10. No Eligible Sales may be recorded on the Website after 11.59pm on 28 February 2021.

14. Staff Entrants must claim prizes via the Website by 11.59pm on 5 March 2021. Any points not used by a Staff Entrant by 11.59pm on 5 March 2021 will be forfeited. Prizes will be delivered to the entrant's business address in Australia or New Zealand, nominated at the time of prize redemption.

15.

(a)

The Platinum Account Store Entrant and the Independent Account Store Entrant that has accumulated the most Eligible Sales with respect to Luxury Frames made between 12.01am on 9 November 2020 and 11.59pm on 22 November 2020 ("Luxury Period") will win the Luxury Prize. Relevant Eligible Sales for the Luxury Period must be recorded on the Website by 11.59pm on 22 November 2020 to count towards the Luxury Prize.

In the case of a tie, the prize will be awarded to the tied Store Entrant where a relevant Staff Entrant first recorded an applicable Luxury Frames Eligible Sale on the Website with respect to the Luxury Period.

The Luxury Prize is a selection of prizes as selected by the Promoter valued at up to \$3,410.

Two (2) Luxury Prizes will be awarded in total and the total prize pool of the Luxury Prizes is up to \$6,820.

The winning Platinum Account Store Entrant and the winning Independent Account Store Entrant of the Luxury Prize will be announced by the Promoter by 26 November 2020 on the Website.

The winning Store Entrants will be contacted in writing by 26 November 2020.

Each winning Store Entrant must claim its prize by 5pm on 26 February 2021 by contacting the Promoter as required by the Promoter. In the event that for any reason whatsoever a winner does not respond to a prize notification within the time period allowed, then the prize will be forfeited by the winner. If necessary, the Promoter may award the Luxury Prize to the next qualifying Store Entrant, subject to any directions given by any relevant authority.

Store Entrants must be free of any overdue debts to the Promoter and any of the Promoter's related body corporate for a Store Entrant to win a prize in the Competition.

The Luxury Prize will be delivered to each winner's business address in Australia or New Zealand.

The Luxury Prize will be provided to the manager of each winning Store Entrant. It is solely up to the winning Store Entrant with respect to how it distributes the Luxury Prize amongst staff.

(b)

The Platinum Account Store Entrant and the Independent Account Store Entrant that has accumulated the most Eligible Sales with respect to Oakley branded eyewear (excluding goggles) made between 12.01am on 23 November 2020 and 11.59pm on 6 December 2020 ("Oakley Period") will win the Oakley Prize.

Relevant Eligible Sales for the Oakley Period must be recorded on the Website by 11.59pm on 6 December 2020 to count towards the Oakley Prize.

In the case of a tie, the prize will be awarded to the tied Store Entrant where a relevant Staff Entrant first recorded an applicable Oakley branded Eligible Sale on the Website with respect to the Oakley Period.

The Oakley Prize is a selection of prizes as selected by the Promoter valued at up to \$2,896.

Two (2) Oakley Prizes will be awarded in total and the total prize pool of the Oakley Prizes is up to \$5,792.

The winning Platinum Account Store Entrant and the winning Independent Account Store Entrant of the Oakley Prize will be announced by the Promoter by 10 December 2020 on the Website.

The winning Store Entrants will be contacted in writing by 10 December 2020.

Each winning Store Entrant must claim its prize by 5pm on 10 March 2021 by contacting the Promoter as required by the Promoter. In the event that for any reason whatsoever a winner does not respond to a prize notification within the time period allowed, then the prize will be forfeited by the winner. If necessary, the Promoter may award the Oakley Prize to the next qualifying Store Entrant, subject to any directions given by any relevant authority.

Store Entrants must be free of any overdue debts to the Promoter and any of the Promoter's related body corporate for a Store Entrant to win a prize in the Competition.

The Oakley Prize will be delivered to each winner's business address in Australia or New Zealand.

The Oakley Prize will be provided to the manager of each winning Store Entrant. It is solely up to the winning Store Entrant with respect to how it distributes the Oakley Prize amongst staff.

(c)

The Platinum Account Store Entrant and the Independent Account Store Entrant that has accumulated the most Eligible Sales with respect to Ray-Ban branded eyewear made between 12.01am on 7 December 2020 and 11.59pm on 20 December 2020 ("Ray-Ban Period") will win the Ray-Ban Prize.

Relevant Eligible Sales for the Ray-Ban Period must be recorded on the Website by 11.59pm on 20 December 2020 to count towards the Ray-Ban Prize.

In the case of a tie, the prize will be awarded to the tied Store Entrant where a relevant Staff Entrant first recorded an applicable Ray-Ban branded Eligible Sale on the Website with respect to the Ray-Ban Period.

The Ray-Ban Prize is a selection of prizes as selected by the Promoter valued at up to \$3,017.95. Two (2) Ray-Ban Prizes will be awarded in total and the total prize pool of the Ray-Ban Prizes is up to \$6,035.90.

The winning Platinum Account Store Entrant and the winning Independent Account Store Entrant of the Ray-Ban Prize will be announced by the Promoter by 7 January 2021 on the Website.

The winning Store Entrants will be contacted in writing by 7 January 2021.

Each winning Store Entrant must claim its prize by 5pm on 7 April 2021 by contacting the Promoter as required by the Promoter. In the event that for any reason whatsoever a winner does not respond to a prize notification within the time period allowed, then the prize will be forfeited by the winner. If necessary, the Promoter may award the Ray-Ban Prize to the next qualifying Store Entrant, subject to any directions given by any relevant authority.

Store Entrants must be free of any overdue debts to the Promoter and any of the Promoter's related body corporate for a Store Entrant to win a prize in the Competition.

The Ray-Ban Prize will be delivered to each winner's business address in Australia or New Zealand.

The Ray-Ban Prize will be provided to the manager of each winning Store Entrant. It is solely up to the winning Store Entrant with respect to how it distributes the Ray-Ban Prize amongst staff.

16. Winners' names and states of residence may be provided to the participating retail stores for distribution and/or announced by the Promoter through social media and/or on any of the Promoter's websites. By entering this Competition, each entrant requests that his or her full address not be published.

17. The Promoter may in its absolute discretion prohibit an entrant's participation in this Competition, cancel a prize or otherwise cease to provide any benefit of a prize to a winner if the entrant or the winner, in the opinion of the Promoter, behaves aggressively or offensively, or behaves in a manner which may diminish the good name or reputation of the Promoter or any of its related bodies corporate (or of the business of the Promoter or any of its related bodies corporate), is contrary to law or is otherwise inappropriate.

18. All entries and materials submitted to the Promoter in connection with this Competition (in any form, including without limitation in hard copy or electronic form), become the property of the Promoter and each entrant warrants that it has the right to transfer these things to the Promoter. The Promoter may use such entries and materials and any intellectual property rights subsisting in them in any medium and in any manner it sees fit, including without limitation, by reproducing, modifying or adapting such entries and materials.

19. If an entrant is unable to or refuses or fails to take part in any element of this Competition, or a winning entry is deemed not to comply with these terms and conditions, the Promoter reserves the right to discard that entrant's entry and proceed as if that entrant had not entered the Competition. The judges' decision is final and no correspondence will be entered into.

20. Entrants acknowledge that there may be inherent risks in some aspects of the Competition, including without limitation a prize and that participation in the Competition and/or using a prize may involve participating in dangerous activities. By entering this Competition and/or accepting the prize, entrants accept that risk.

21. Prizes and participation in the Competition are subject to any conditions imposed by the supplier or organiser of the prizes, as applicable. All vouchers and gift cards are subject to the conditions stipulated by the provider of the voucher or gift card. Without limiting any other paragraph in these terms and conditions, the Promoter and its associated agencies and companies make no warranties or representations about the fitness for purpose or suitability of the prize and will not accept responsibility for the quality or fitness for any purpose of any element of the prize, or the failure of any element of the prize to be of merchantable quality. If liability under terms implied by legislation cannot be excluded, the liability of the Promoter is the minimum allowable by law.

22. The Promoter may require a winner to provide identification as requested by the Promoter including (without limitation) proof of identity, proof of age and proof of residency. Identification considered suitable for verification is at the Promoter's discretion.

23. If due to any reason whatsoever the Promoter becomes aware after an entrant has won a prize and that the entrant has not complied with these terms and conditions, that entrant will have no

entitlement to the prize, even if the Promoter has announced him/her/it as a winner and that entrant will be required, at the direction of the Promoter, to return, refund or otherwise make restitution of the prize.

24. The Promoter may, in its sole discretion, disqualify any or all entries from, and prohibit further participation in this Competition by, any person who tampers with or benefits from any tampering with the entry process or with the operation of the Competition or acts in violation of these terms and conditions, acts in a disruptive manner or acts with the intent to annoy, abuse, threaten or harass any other person.

25. No prize is transferable or exchangeable, nor can it be redeemed for cash. If for any reason a winner does not take an element of the prize at the time stipulated by the Promoter then that element of the prize will be forfeited by the winner and cash will not be supplied in lieu of that element of the prize. The Promoter accepts no responsibility for any variation in prize value. Where an element of a prize is unavailable for any reason, the Promoter may substitute for that element of the prize another item of equal or higher value as determined by the Promoter, subject to the approval of the relevant authorities, if required. Without limiting the foregoing, the Promoter may, at its absolute discretion, substitute cash for any prize (the amount of cash being equal to the element of the prize value specified in these terms and conditions).

26. If for any reason any aspect of this Competition and/or the prizes is not capable of running as planned, including by reason of war, terrorism, state of emergency, disaster, infection by computer virus, telephone network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Competition and/or the prizes, or invalidate any affected entries, subject to the approval of the relevant authorities, if required.

27. Without limiting any other paragraph, the Promoter may at its discretion amend any aspect of this Competition or of these terms and conditions, subject to applicable laws and subject to the approval of the relevant authorities, if required.
